

2012 NJEA and ACCEA Elections

Procedures and Eligibility



Local Presidents: It's election time again and time for your Executive Boards to appoint a representative for Atlantic County's nominating committee. The nominating committee will be meeting during ACCEA Overnight Workshops, which will be held February 10-11, 2012, at Bally's Atlantic City.

The "Rules for NJEA Elections" require a selection of no more than **29** local delegates to be named to the County Nominations Committee, with a minimum of **15** needed for candidate approval. Both NJEA Active Professional and Active Supportive Members are eligible to serve on the committee. Affiliates, which are entitled to have representation on the county committee, to be appointed by the executive board of the respective local affiliate, include:

- 4- Atlantic City E.A
- 1- Hamilton Twp. E.A.
- 1- Atlantic County Special Services E.A.
- 1- Hammonton E.A.
- 1- Buena Reg. E.A.
- 1- Greater Egg Harbor Reg. E.A
- 4- Egg Harbor Twp E.A.
- 2- Pleasantville E.A.
- 2- Galloway Twp. E.A.

All other affiliates may have one member representative on the committee.

2. Presidents are asked to notify their appointed member of the County Nominations meeting to be held at the ACCEA Overnight at Bally's. A specific time will be established later.

3. Selection of ballot placements will be drawn on March 8th.

Nominating Petitions for RA are available on-line at the NJEA website. Atlantic County is entitled to 6 representatives.

This year, Atlantic County will elect the following NJEA State Positions:

- 1 Executive Committee member for a term expiring in 2015
- 2 Delegate Assembly members for terms expiring in 2014
(Not from Greater Egg Harbor Reg. or Mainland Reg.)
- 2 Delegate Assembly Alternates for full terms expiring in 2014 (Not from Mullica Twp.)
- 1 Delegate Assembly Alternate for a term expiring in 2013 (Not from Mullica Twp.)
